PARTIES: This memorandum of Understanding is made and entered into by and between the T.I.M.E. Vellore and Auxilium College of Arts and Science for Women, Vellore, Tamil Nadu.

PURPOSE: The purpose of this MOU is to establish the terms and conditions under which T.I.M.E. Vellore will conduct its class for Competitive Exam Training and seminar sessions in the premises of Auxilium College, Vellore for its students.

Terms of MOU:

- T.I.M.E. Vellore will provide the **course material & classes** and Auxilium College, Vellore will be providing class rooms and necessary arrangements for conduct of classes.
- The **course coverage hours** will be provided by T.I.M.E. Vellore and Auxilium College, Vellore will not allot the necessary hours for the same.

R. K. Srinivasan

sole arbitrator appointed by both T.I.M.E. Vellore and Auxilium College, Vellore, failing which the sole arbitrator shall be appointed in accordance with the arbitration and conciliation act, 1996, and /or any statutory modifications or re-enactment thereof for the time being in force the dispute arose. Arbitration shall be in Vellore and the proceedings shall be conducted in English Language. However the performance of the T.I.M.E. Vellore contractual obligations shall not be suspended pending settlement of disputes provided the other obligations of the college to T.I.M.E. Vellore is met.

- k) The occurrence of a Force majeure event shall suspend the performance of the parties obligations under the agreed terms and conditions until the force Majeure event has ceased, except those relating to confidentiality, patents and protection of services. Each party shall bear its own consequences and costs resulting from the occurrence of a Force Majeure event.
- l) The MOU may be extended provided the parties agree upon, and can provide the necessary resources.
- m) The contract will be valid for a period of one year starting from 07/01/2019 and ending on 07/01/2020. Both Auxilium College, Vellore and T.I.M.E. Vellore agrees not to terminate this arrangement unless mutually agreed in writing.
